ALL STATE ROWS, SPECIAL CLUBS, MERCHANTS ROW AND CRAFTS ROW WILL BE PARKED IN ELECTRIC SITES. ALL SALES WILL BE CONDUCTED IN FRIENDSHIP HALL, MERCHANTS ROW OR CRAFTS ROW ONLY.

MERCHANTS ROW—An area set aside for WIT members, staying in coaches from which they sell only **COMMERCIALY PRODUCED** articles. LIMITED SITES. Sales are subject to Iowa Sales Tax. Contact Rosie Dirksen, GNR Coordinator, 641-585-6464, for more information on Merchants Row.

WIT CRAFTS ROW—An area set aside for WIT members, staying in their coaches from which they sell only **HAND CRAFTED** articles. LIMITED SITES Sales are subject to Iowa Sales Tax. Contact Rosie Dirksen, GNR Coordinator, 641-585-6464, for more information on Crafts Row.

MILWIT CLUB—Open only to members of the MILWIT Club who are active or retired military and their spouses.

WIT SINGLES CLUB—Singles only.

WIT LEO CLUB—Open only to members of WIT LEO, past and present law enforcement officers.

NO-TOW BAGOS CLUB—Winnebago Industries H-class owners who choose not to tow a vehicle.

WIT 365 CLUB—Open only to members of the 365 Club (Those living in their unit at least six months out of the year.)

WIT RADIO CLUB—Open only to members of the WIT Amateur Radio Club.

NETWIT CLUB—Computer Club members

WIT RODs—Open to members of WIT RODs Club.

WIT HANDICAP CLUB—Members of the Handicap Club will be given first consideration in the handicap parking area.

RESTRICTIONS FOR MERCHANTS ROW ONLY:

- 1) You may not sell, without prior approval, any item represented by a Winnebago Industries vendor selling in Friendship Hall or offered by Winnebago Customer Service Retail Stores.
- 2) You may not display product in a manner in which it represents a "flea market."
- 3) You may sell only those products listed above that are approved. WIT members must own their coach from which sales are being conducted.
- 4) You may be required to discontinue the sale of a certain product and/or required to modify your display if items are not listed on form.
- 5) Final approval will not be granted until after April 15, 2009.

Cancellation Policy

***A cancellation fee of \$35 will be charged for ALL cancellations. 2009 GNR registration fee cannot be transferred to another unit or WIT event.**

* If you wish to cancel your reservation for Grand National Rally, WIT must be notified in writing. Date of receipt of written notice at the WIT office is the effective date of cancellation. WIT will retain a \$35 cancellation fee if reservation is cancelled prior to June 15, 2009. If reservation is cancelled after June 15, 2009, **for any reason**, WIT will retain a \$35 cancellation fee; however, if your reservation included electric and we are not able to fill your site, WIT will retain 50 percent of

the total registration fee. **If your reservation is cancelled within seven days prior to start of the rally, WIT will retain the entire registration fee.**

If you wish to cancel any of your pre-rally activities, WIT must fill the resulting vacancy before a refund can be given. If through an Act of God, WIT is unable to park your motor home on the River Oaks Rallygrounds and alternate parking is provided, your refund will be limited to the difference between the cost of dry parking and the cost of an electric site. Normal processing time is 6-8 weeks after receipt of cancellation.
